2. Sickels & Associates, Inc. letter dated July 20, 2017 regarding Sanitary Sewer Easement Review No. 1 for Tri-County Real Estate Maintenance Company, Inc. relating to the Laytons Lake Subdivision. This letter confirms that the East End Avenue Pumping Station, which will receive the flow from the KAST Distributors warehouse development project, has sufficient additional capacity to convey the projected flow of 1,660 gallons per day. Mr. Adam Telsey wanted it noted that he represents KAST Distributors in the event a matter should occur.

# Superintendent's Report

Mr. DeBlock reported the following:

RBC 2C remains off line pending shaft replacement.

Average daily flow for the month of July was 0.781 MGD. Average daily flow for the month of August to date is 0.745 MGD.

Flows continue to remain lower then historically reported.

The manhole cover and frame have been replaced in the alley behind 29 E. Line Street.

The Line Street Pump Station wet well has been cleaned.

A Backup High Level alarm has been installed at Line Street.

Responses have been provided for the Loss Control Report.

Preventative maintenance logs are being updated as requested in the Loss Control Report provided by CAN Risk Control.

Authority Operations Staff are confirming connected load during generator testing. Quotes are being solicited for a logging ammeter.

## **Business Office Report**

Mrs. Cleary's report reflects July monthly revenue of \$141,094.49. Operating expenses of \$100,967.98. In addition, a payment for Hickory Ave. Pump Station in the amount of \$18,371.08 and a payment for Phase 2 Sanitary Sewer Improvements in the amount of \$187,030.55. Total payments in July were \$306,369.61.

Online payment activity continues to increase each month.

The Tax Sale is scheduled for October 16, 2017.
