### Reports

### Solicitor's Report

Mr. Telsey had nothing to report.

#### **Engineer's Report**

Mr. Biermann reported the following:

The Route 130 & Hollywood Avenue Roundabout (NJDOT Project) that Sickels & Associates has reviewed the documentation submitted by the NJDOT's engineer, Taylor, Wiseman & Taylor (TWT) for the sanitary sewer work involving replacement and resetting of a manhole frame and cover at Shell Road (Rt 130) and Bianco Avenue. There were no objection to their proposed work.

Regarding the Delaware Avenue Pump Station Force Main, an odor control chemical feed, Bioxide, was initiated at the pump station in an effort to reduce the odors in the Gary Avenue area.

Sickels & Associates are currently in disagreement with the contractor of the E-Street Sanitary Sewer Replacement project regarding the project completion and are presently working out an alternative for removal and disposal of the soil pile and cleanup of the site. The Salem County Landfill has agreed to take the soil and use as an alternate daily cover. It was suggested to close out the project with the current contractor and hire another contractor to remove the soil, take it to the landfill and clean up the site. A suggestion was made to install a temporary 6 foot chain link fence surrounding the pile until it is able to be removed.

### Superintendent's Report

Mr. Robert DeBlock reported the following:

The RBC operation remains satisfactory. Shaft 2B has been restored and in service.

The RBC Shaft 2C has failed and will need to purchase a new shaft and have a contractor remove the existing shaft and install the new one. It was requested authorization for the authority engineer to prepare specifications and solicit bid proposals to repair RBC 2C. On motion by Mr. Rullo, seconded by Mr. Gatanis it was moved to proceed with the authority engineer to prepare specifications and solicit bid proposals to repair RBC 2C.

Mr. Robert DeBlock provided an update regarding Gary Avenue. He explained that the pilot bioxide feed system and H2S monitoring of Gary Avenue have been installed and are operational. Manhole inserts for the Gary Avenue area have been installed by Authority staff.

Mr. Robert DeBlock spoke to the owner of the Red Carpet Inn regarding the need to provide evidence of compliance with the Authority Rules and Regulations for sewer disconnection. The owner is having the contractor contact Mr. Robert DeBlock to discuss arrangements for inspection.

Mr. Robert DeBlock said that he will develop a form for the disconnection of sewer requests as a requirement to be completed by the property owner prior to approving the discontinuation of sewer billing. Once this form is developed, Mr. Robert DeBlock will forward it to the authority's solicitor for review.

### **Business Office Report**

Mrs. Cleary's report reflects January monthly revenue of \$169,296.34 and expenses of \$72,977.54.

Edmunds was contacted regarding auto payments through the authority's website. The annual service fee is \$600. On motion by Mr. Rullo, seconded by Mr. Pelura it was moved to proceed with the Web Inquiry and Payment Portal through Edmunds.

It was recently discovered that the authority back up data files are on the same server as the current data files. In the event of a catastrophic system malfunction, all data is at risk to be lost. It was agreed to purchase two separate external hard drives as a temporary solution. Terrance R. Layfield Computer and Networking consultant will be contacted for virtual options and prices. It was suggested to inquire how Carneys Point Township backs up their data.
