- 5. Telsey & Telsey, LLC Attorneys At Law letter dated July 6, 2017 to Bowman and Company, LLP contained information required for the yearly examination of the Carneys Point Township Sewerage Authority's Financial Statement.
- 6. Sickels & Associates, Inc. letter dated July 11, 2017 regarding request for evaluation of the sanitary sewer availability and capacity for Block 250, Lots 1, 1.01, 2, 2.02, 7, 8, 8.03. ARBOK Partners, LLC contacted Sickels & Associates, Inc. regarding an interest in developing a parcel of land that sits between Route 40, New Jersey Turnpike, Courses Landing Road and Route 48 (Harding Highway). Reports

Solicitor's Report

Mrs. Telsey had nothing to report.

Engineer's Report

Mr. Biermann reported the following:

Miller Avenue Pump Station Transfer Switch replacement complete. The performance bond was received and have no objection to the Authority releasing final payment to the contractor.

Route 295 Pump Station Gravity Main Reconstruction:

a. The sanitary sewer main has been repaired with 300 feet of new PVC pipe. We found that the existing asbestos concrete pipe was extremely deteriorated and crumbled as it was exposed and excavated. The new main is now in service and the system is again flowing. Site restoration work is ongoing. Once the access road is clear and passable, the contractor will jet/vac clean and video the repaired section and the sanitary sewer mains immediately upstream and downstream of the repair.

Layton's Lake Subdivision:

- a. Work is ongoing. Inspection of additional sewer sections is to be scheduled.
- b. Applicant has submitted a new easement for a portion of the sanitary sewer main through Block 233.01 Lot 3. Sickels & Associates, Inc. has reviewed the easement and have no technical concerns regarding the easement as drafted and described.

US4 Realty, LLC – 424 Harding Highway (Block 68, Lot 5.03). The project has been approved. However, the connection cannot be made without reconstruction of the receiving manhole at the East End Avenue Pump Station. The Carneys Point Township Sewerage Authority board will need to review finances to determine the status of reconstructing the manhole at this location.

Sanitary Sewer Operating Mapping – This is included on the list of Capital Projects for review. Additional information regarding this proposal will be provided at the next board meeting.

Superintendent's Report

Mr. DeBlock reported the following:

RBC 2C remain off line pending shaft replacement.

The Secondary Effluent Pump Station operation is satisfactory. Pump 3 requires replacement and is on the list of Capital Projects for review.

Average daily flow for the month of June was 0.879 MGD. Average daily flow for the month of July to date is 0.745 MGD.

21 feet of gravity main were replaced on Oakwood and Fairview Streets.

Gary Avenue Update: The pilot bioxide feed system and H2S monitoring of Gary Avenue are still in progress. Results are forthcoming.

JIF mid-year safety report has been submitted.

Authority staff has inspected the water meter at NFI Industries and have confirmed that there is only one meter.

DeBlock Environmental Services, LLC is working with the Authority Engineer and Auditor to review capital projects and potential funding options available to the board.

Business Office Report

Mrs. Cleary's report reflects June monthly revenue of \$218,909.83 and expenses of \$106,949.81.

Online payment activity continues to increase each month.

Michael Welding from Bowman and Company, Jeff Winitsky from Parker McCay and Michael Cleary from Carneys Point Township Sewerage Authority attended the Local Finance Board Hearing on July 12, 2017 for the rollover of the 2017 Project Notes.

2nd Quarter Consumption Invoices will be sent out by Friday, July 21, 2017.
