## **RESOLUTION 2018-7**

## RENEWAL OF SHARED SERVICE AGREEMENT BETWEEN CARNEYS POINT TOWNHSIP AND CARNEYS POINT SEWERAGE AUTHORITY FOR COMPUTER CONSULTANT SERVICES

WHEREAS, Carneys Point Township, hereinafter referred to as "Township," with principal offices located at 303 Harding Highway, Carneys Point, New Jersey 08069 and the Carneys Point Township Sewerage Authority, hereinafter referred to as "Authority," with principal offices located at 303 Harding Highway, Carneys Point, New Jersey 08069, have determined to enter into a Shared Services Agreement pursuant to the provisions of the Uniform Shared Services and Consolidation Act, P.L. 2007, c 63 (C:40A:65-1, et seq.); and

WHEREAS, THE Uniform Shared Services and Consolidation Act, P.L. 2007, c63 (c: 40A:65-1, et seq.) authorizes and empowers the Parties to enter into this Agreement; and

WHEREAS, the Parties have adopted Resolutions and/or Ordinances to authorize this Agreement; and

WHEREAS, this Agreement provides for certain Information Technology support Services ("IT Support") to be provided by Carneys Point Township to Carneys Point Sewerage Authority in accordance with the terms and conditions set forth herein; and

WHEREAS, this Shared Services Agreement is subject to resolutions of the Governing Bodies of Carneys Point Township and Carneys Point Sewerage Authority approving same; and

WHEREAS, THE Parties have filed a copy of this Agreement with the Division of Local Government Services in the Department of Community Affairs pursuant to (C: 40A:65-4);

NOW, THEREFORE, in consideration of the terms and condition hereinafter set forth, the parties agree as follows:

- 1. The Carneys Point Township Sewerage Authority will utilize the services of Carneys Point Township's IT Consultant, Wesley Barber of Barber Consulting Services, LLC.
- 2. The annual fee for services is \$1,500.00 (pro-rated)
- 3. Hourly service will be billed at the rate of \$65.00.
- 4. Carneys Point Township will absorb the cost of the initial visit and consultation of Barber Consulting Services.
- 5. The IT Services to be provided by Barber Consulting consists of:
  - a. Phone Support and remote support from 8:00 am to 6:00 pm Monday through Friday
  - b. Additional hours will be billed at the discounted rate of \$65.00/hr

- c. Additional onsite visits will incur a 2 hour travel fee in addition to the \$65.00/hr rate
- d. Support hours used from 6:00 pm to 8:00 am on weekends and any hours used on weekends and holidays will be billed at the emergency rate of \$130.00 per hour per technician.
- e. All parts, supplies or software needed for repairs, maintenance or upgrades will be purchased by the Carneys Point Sewerage Authority.

This Agreement shall be in effect for a term beginning June 7, 2017 and ending December 31, 2017. This Agreement shall renew, on an annual basis, unless either party provides not less than sixty (60) days advance notice of non-renewal to the other party.
