WHEREAS, a sewerage connection fee of \$8,890.00 shall be paid to Carneys Point Township Sewerage Authority for Barber Shop and Massage Parlor site (Block 197, Lot 5). The applicant shall forward the connection fee to the Carneys Point Township Sewerage Authority business office at 303 Harding Highway, Carneys Point, NJ 08069.

THEREFORE BE IT RESOLVED that the Carneys Point Township Sewerage Authority approves the application for construction of the sanitary sewer improvements subject to the conditions in the referenced Authority Engineer's letters, replenishment of the review escrow, payment of the connection fee, and posting the Safety & Stabilization and performance Guarantees, and posting the estimated escrow fees for Barber Shop and Massage Parlor site (Block 193, Lot 6) S&A file #CPSA-1011.
