RESOLUTION APPROVAL OF APPLICATION FOR SANITARY SEWER IMPROVEMENTS, ESTABLISHMENT OF ESTIMATED ESCROW FEES, ESTABLISHMENT OF THE SAFETY & STABILIZATION GUARANTEE, PERFORMANCE BOND/GUARANTEE AND ESTABLISHMENT OF THE SEWERAGE CONNECTION FEE FOR SALEM COMMUNITY COLLEGE GLASS EDUCATION CENTER BLOCK 170, LOT 2 & 2.01 TOWNSHIP OF CARNEYS POINT, SALEM COUNTY

WHEREAS, the Carneys Point Township Sewerage Authority requires the application for sanitary sewer improvements for Salem Community College Glass Education Center (Block 170, Lot 2, 2.01) located within the Township of Carneys Point; and

The applicant shall forward the escrows and guarantees to the Carneys Point Township Sewerage Authority business office at 303 Harding Highway, Carneys Point, NJ 08069; and

WHEREAS, a sewerage connection fee of \$22,225.00 shall be paid to Carneys Point Township Sewerage Authority for said project. The applicant shall forward the connection fee to the Carneys Point Township Sewerage Authority business office at 303 Harding Highway, Carneys Point, NJ 08069.

THEREFORE BE IT RESOLVED that the Carneys Point Township Sewerage Authority approves the application for construction of the sanitary sewer improvements subject to the conditions in the referenced Authority Engineer's letters, replenishment of the review escrow, payment of the connection fee, and posting the Safety & Stabilization and performance Guarantees, and posting the estimated escrow fees for Salem Community College Glass Education Center (Block 170, Lots 2, 2.01).
