**RESOLUTION OF THE TOWNSHIP OF CARNEY'S POINT APPROVING THE FILING OF GRANT FUNDING AND A LOAN TO FUND THE OVERALL ENGINEERING AND INFRASTRUCTURE IMPROVEMENTS NEEDED TO EXPAND THE CARNEY'S POINT TOWNSHIP SEWERAGE AUTHORITY (CPTSA) SANITARY SEWER SYSTEM**

**WHEREAS**, the CPTSA has determined the need to expand the capacity of the CPTSA Sanitary Sewer System to serve its existing residential units and potential incoming commercial and economic development in the Township's designated redevelopment zone; and,

**WHEREAS**, it is necessary for the CPTSA to seek favorably-termed funding to carry out this project as they cannot solely afford to fund the project;


**WHEREAS**, the USDA has opened applications for the Rural Development Water & Waste Disposal (W&WD) Grant Program to fund such infrastructure improvements as a force main; and,

**NOW, THEREFORE, BE IT RESOLVED**, that an application to the USDA W&WD Grant Program to fund the infrastructure improvement project is hereby in all respects approved and be it further resolved that the Chairman or his designee and the City Clerk are hereby authorized to execute all documents associated with the application, and;

**BE IT RESOLVED**, that the CPTSA does hereby authorize the filing of a full application for USDA W&WD grant and loan funding in an amount not to exceed \$2,000,000 in grant funding and \$5,000,000 in loan funding; and,

**BE IT FURTHER RESOLVED** that, should the loan be awarded to CPTSA, the Chairman or his designee and the City Clerk are hereby authorized to execute all documents associated with the implementation for USDA W&WD funding.




