WHEREAS, under the Local Public Contracts Law, N.J.S.A. 40A:11-1, et. seq., the subject contract would be a contract for professional services; and

WHEREAS, as a professional services contract, the subject contract could have been awarded without utilization of the fair and open process that was used; and
