# **Resolution Authorizing Contract for Licensed Operator Services**

**WHEREAS**, The Carneys Point Township Sewerage Authority ("CPTSA") is in need of an S3 licensed operator to satisfy NJDEP licensing requirements; and

WHEREAS, Environmental and Technical Services, LLC ("ETS") firm possesses the necessary expertise and licensing; and

WHEREAS, the CPTSA would like to hire ETS for this work; and

**WHEREAS**, the award of the contract is being made in accordance with N.J.S.A. 19:44A-20.5 and N.J.S.A. 40A: 11-5(1)(a)(i) as it is a professional service; and

WHEREAS, the CPTSA has determined that the value of the services is anticipated to exceed \$17,500 during the term of this contract and funds are available; and

WHEREAS, ETS has submitted a proposal regarding their fees, which is attached to this Resolution; and

WHEREAS, ETS has completed and submitted a Business Entity Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Carneys Point in the previous one year, and that the contract will prohibit making any reportable contributions through the term of the contract; and

**NOW, THEREFORE BE IT RESOLVED,** by the CPTSA that a three-year contract with ETS to perform the above-mentioned services as outlined in its proposal is authorized and the Chairman may execute the contract in the form approved by the Solicitor.

**BE IT FURTHER RESOLVED,** that the Business Disclosure Entity Certification and Determination of Value be placed upon file with this resolution; and

Dear Sir:

As requested, Environmental & Technical Services (ETS) is pleased to offer the following:

### **Understanding of Project:**

It is our understanding that Carneys Point Sewerage Authority is required by New Jersey Department of Environmental Protection (NJDEP) to employ a firm/employee to meet the requirements of a S3 Licensed Operator at a minimum of 35 hours per week to satisfy the NJDEP licensing requirements and to provide oversight of the on-staff employees.

#### Scope of Work:

Environmental & Technical Services, LLC (ETS) does agree to provide the services enumerated below and such other services that may be required, but not limited to:

- 1. Provide NJDEP S-3 certified operator to ensure regulatory compliance of the wastewater treatment plant and collection system including testing and reporting to the state and other governing entities necessary to maintain all certifications. NJDEP certified operator shall be assigned as operator of record at a minimum of 35 hours per week.
- 2. Review current wastewater monitoring and recordkeeping; identifying areas where monitoring or sources are not in compliance with regulations and if applicable take appropriated actions to ensure that violations are corrected, deleted or validated. ETS shall be responsible for all financial penalties resulting from notices of violation issued by NJDEP in connection with the services rendered pursuant to this contract resulting in negligence of the licensed operator.
- 3. Provide oversight of wastewater discharge quality, ensure monitoring is conducted according to the established NJDEP Permit #NJG0200751 and NJ0021601, ensure that NJDEP schedule is correct and appropriate and that the data submitted to NJDEP is accurate and timely.

- 4. Review results and reports to determine that the wastewater discharge complies with the State and Federal regulations.
- 5. Provide oversight of offsite laboratory performing the required monitoring samples.
- 6. Continuously review monitoring of the wastewater treatment plant discharge to assure that discharge quality is meeting the State and/or Federal regulations.
- 7. Provide guidance where opportunities exist to reduce operational costs of the wastewater and collection system.
- 8. Take immediate appropriate action if a violation occurs.
- 9. Provide a monthly report to Carneys Point Sewerage Authority on wastewater operations.
- 10. Attend monthly Carneys Point Sewerage Authority meetings.
- 11. Provide advice and technical assistance on how to comply with the State and Federal Regulations.
- 12. Ensure Carneys Point Sewerage Authority Staff understand the wastewater regulations, identify training needs for the wastewater system on-staff personnel.
- 13. Act as a liaison between Carneys Point Sewerage Authority and NJDEP to report sewer overflows or malfunctions within the wastewater treatment and collection system.
- 14. Ensure that wastewater discharge meters are calibrated per NJDEP and manufacturer's specifications.
- 15. Provide oversight for responses to emergency situations 24 hours per day, 7 days per week.
- 16. ETS agrees to provide and maintain insurances set forth in Exhibit A attached hereto and made part hereof.
- 17. ETS will provide an individual to fill the position for the onsite Laboratory Manager of record as required by NJDEP.

In addition to the above, ETS will provide a C-2 licensed operator of record and perform oversight of the sewer collection system at no additional charge to the Authority.

In consideration whereof, said Carneys Point Sewerage Authority and ETS, both promise and agree that the Carneys Point Sewerage Authority shall and will in consideration of the covenants and agreements herein contained being strictly performed and kept by ETS as specified, pay or cause to be paid, unto ETS;

- 1. Year 2024: \$8,538.00 per month for non-emergency work
- 2. Year 2025: \$8,927.00 per month for non-emergency work
- 3. Year 2026: \$9,284.00 per month for non-emergency work \*\$90.00 per hour for emergency work\*

Either party can terminate this contract by sixty days written notice. This contract is a three (3) year contract from date of execution.
