## CARNEYS POINT TOWNSHIP SEWERAGE AUTHORITY RESOLUTION NO. 2024-25

## AWARDING CONTRACT TO Eric M. Krise Electrical Contractor

WHEREAS, the Carneys Point Township Sewerage Authority (CPTSA) operates a "Wastewater Treatment System," as that term is defined in the Local Public Contracts Law at N.J.S.A. 40A:11-15(19); and

WHEREAS, the Local Public Contracts Law, at N.J.S.A. 40A:1 l-5(1), provides that a contract, the price of which exceeds the current bid threshold, may be negotiated and awarded without public bidding if the subject matter of the contract consist of: "(gg) a contract for the provision of... a wastewater treatment system as defined in [N.J.S.A. 40A:11-15(19) or any component part or parts thereof;" and

**WHEREAS**, the CPTSA has a need to rehabilitate two modules of the Aquaray 40 Ultraviolet Disinfection System located at the CPTSA wastewater treatment plant.

WHEREAS, the Aquaray 40 Ultraviolet Disinfection System is a component part of the wastewater treatment system that is operated by the CPTSA; and

WHEREAS, Eric M. Krise Electrical Contractor has the credentials and ability to supply the CPTSA with the parts and labor needed to rehabilitate the Aquaray 40 Ultraviolet Disinfection System and has submitted a proposal, dated January 22, 2024 indicating that it will provide the CPTSA with all labor materials, testing and installation for rehabilitation two modules of the disinfection system in the amount of \$58,843.56; and

WHEREAS, the value of the aforementioned contract will exceed \$17,500.00 and, therefore, the proposed contract would fall within the scope of N.J.S.A. 19:44A-l.5; and

WHEREAS, Eric M. Krise Electrical Contractor has completed and submitted (or will complete and submit prior to execution of the contract authorized by this Resolution) a Business Entity Disclosure Certification that certifies that Eric M. Krise Electrical Contractor has not made any reportable contributions to a political or candidate committee in Carneys Point Township in the previous one year, and that the contract will prohibit Eric M. Krise Electrical Contractor from making any reportable contributions through the term of the contract;

**NOW, THEREFORE, BE IT RESOLVED,** by the Members of the Carneys Point Township Sewerage Authority, in the County of Salem and State of New Jersey, as follows:

- 1) All of the statements of the preamble are incorporated herein by this reference thereto as though the same were set forth at length.
- 2) The Authority Chairman and Authority Secretary be and they hereby are authorized to execute a contract with Eric M. Krise Electrical Contractor., a term of which incorporates the

aforementioned January 22, 2024, proposal, to refurbish, repair, test and install two modules of the Aquaray 40 UV Light System at a total cost not to exceed \$58,843.56.

- 3) The statutory language required by N.J.S.A. 10:2-1 and 10:5-33 hereby is incorporated into the contract by reference and the contractor is bound by said language together with the other provisions of the anti-discrimination laws of the State of New Jersey, Chapter 127 of the Laws of 1975.
- 4) This Resolution shall only be effective when a copy of a certification of availability of funds prepared by the Certifying Finance Officer of the CPTSA is attached hereto.
- 5) The Business Entity Disclosure Certification and the determination of value shall be placed on file with this Resolution.
- 6) This Resolution shall only become effective when a copy of the New Jersey Business Registration Certificate by Eric M. Krise Electrical Contractor . is submitted to the Carneys Point Township Sewerage Authority pursuant to the provisions of N.J.S.A. 52:32-44b(l) and a copy of that New Jersey Business Registration Certificate shall be placed on file with this Resolution.
- 7) A notice of the letting of this contract shall be published in the CPTSA official newspaper within ten (10) days of the date of this resolution, which notice shall state that this Resolution and the contract are on file and available for public inspection in the office of the Carneys Point Sewerage Authority.

8) I hereby certify that the foregoing is a true and exact copy of a resolution introduced and adopted by the Carneys Point Township Sewerage Authority at a meeting held on March 19, 2024.
