RESOLUTION OF THE CARNEYS POINT TOWNSHIP SEWERAGE AUTHORITY, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE NEW JERSEY LOCAL FINANCE BOARD PURSUANT TO N.J.S.A. 40A:5A-6

WHEREAS, The Carneys Point Township Sewerage Authority ("Authority"), desires to make application to the New Jersey Local Finance Board for its review and/or approval of the issuance of the Authority's Project Notes, Series 2025, in a principal amount not-to-exceed \$12,000,000 ("2025 Notes"), the proceeds of which will be used to temporarily finance a forcemain expansion project ("Project") pursuant to *N.J.S.A.* 40A:5A-6;

WHEREAS, the Authority believes that:

- (a) it is in the public interest to accomplish such purposes;
- (b) said purposes or improvements are for the health, welfare, convenience or betterment of the inhabitants of the Township;
- (c) the amounts to be expended for said purposes or improvements are not unreasonable or exorbitant; and
- (d) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the Township and will not create an undue financial burden to be placed upon the Township.

NOW, THEREFORE, BE IT RESOLVED BY THE CARNEYS POINT TOWNSHIP SEWERAGE AUTHORITY AND THE MEMBERS THEREOF, AS FOLLOWS:

<u>Section 1.</u> The application to the New Jersey Local Finance Board is hereby approved and the Authority's Bond Counsel, General Counsel and Municipal Advisor, along with other representatives of the Authority are hereby authorized to prepare such application and to represent the Authority in matters pertaining thereto.

<u>Section 2</u>. The Secretary and the Chairperson of the Authority are each hereby directed to prepare and file a copy of this resolution with the New Jersey Local Finance Board as part of such application.

- <u>Section 3</u>. The New Jersey Local Finance Board is hereby respectfully requested to consider such application and to report its findings, recommendations and/or approvals as provided by the applicable New Jersey law.
- <u>Section 4.</u> This resolution shall take effect immediately upon adoption this 17th day of December, 2024.


